## **Trade Show Terms & Conditions**



The organizing committee would like to provide trade show access to all who wish to participate; however, it is necessary to establish certain guidelines for acceptance of exhibitors on the trade show floor. While every effort will be made to accommodate all who wish to participate, the Organic Connections Board of Directors reserves the right to exclude those displays which do not meet the requirements below.

#### **Products**

Preference will be given to organic products/services. Any products making an 'organic' claim must be certified by a recognized organic certification body. This includes the production and processing of the product. Please submit a copy of the products organic certificate with your application.

#### **Soil Amendments/Permitted Substances**

All products falling into this category must be approved by an accredited organic certification body. Non approved substances will be excluded.

### **Trade Associations & Industry Groups**

For any association or group that does not have a readily apparent relationship with the organic industry, a brief policy statement detailing the relationship is required. The committee reserves the right to exclude any association which is deemed to be outside the scope of the conference theme.

#### Insurance

Confirmation of Exhibitor Insurance is required as follows:

- 1. The tradeshow exhibitors need to provide \$2,000,000.00 liability.
- 2. The tradeshow exhibitor should consider a minimal amount of Tenants Legal Liability.
- 3. The tradeshow exhibitor should include as an additional insured Organic Connections Inc., the City of Saskatoon and TCU Place.
- 4. The certificate of liability should show items 1-3 inclusive.

#### **Booth Details**

**Triple Corner** Booth measures 20' x 20' x 8' deep and includes 2 tables, your choice of

6' X 2' and 8' X 2' skirted and clothed tables, 4 folding chairs and two

conference passes.

**Not for Profit** Booth measures 10' wide by 8' deep and includes your choice of either a

6' X 2' or an 8' X 2' skirted and clothed table, 2 folding chairs and one

conference pass. [Proof of non – profit status is required]

Set up time runs from 8:00 am to 12:00 pm Sunday, November 21. Tear down of booths must not commence prior to 3:30 pm but must be completed by 6:00 pm on Tuesday, November 23, 2010.
